With due respect, I have the honour to report the following few lines that on 8th June,2023 at about 4:00 pm some unknown person suspected to be Kuki militants & kuki rioters opened fire towards Meitei populace area of Leimakhong Chingmang, IW district and torched many houses & vandalized of Meitei community. In that incident, the Kuki armed militant had looted Village Development & Protection Committee property. The property looted by Kuki militant are (1) Sound Box - 8 nos., (2) Mike Horn - 12 nos., (3) Mike Machine - 4 nos., (4) Microphone - 20 nos., (5) Bluetooth Mike - 8 nos., (6) Microphone Stand Box - 2 nos., (7) Microphone Stand - 12 nos., (8) Chair - 300 nos., (9) Microphone wire - 15 nos., (10) Phaksang - 20 nos., (11) VIP table - 10 nos., (12) VIP Chair - 20 nos., (13) Seminar - 6 nos., (14) Halogen light - 20 nos., (15) Tube light - 100 nos., (16) Generator - 2 nos., (17) Cable electric wire - 8 nos., (18) Bench - 50 nos., (19) Material box - 12 nos., (20) Karnat - 20 nos., (21) Carpet - 40 nos., (22) Phijang Items - 1 set, (23) Mandop decoration item - 1 set ( Long Coloured cloth and Disco Light), (24) Stage Material. The approximate value of looted properties are estimated at Rs. 35,00,000/- (Rs. Thirty five lakhs) approximately.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
