In that, the said suspected to be Kuki Militants had trespass my house and looted The following items:-

 - c. Electric Planner Rs. 24,000/-
 - d. Router- Rs. 24,000/-
 - e. Grinder- Rs. 8.100/-
 - f. Drilling M/c -Rs. 8,400/-
 - g. cutter M/C Rs. 6000/-
- 2. Washing Machine- Rs. 18,000/-
- 3. Kitchen items- Rs. 20,000/-
- 4. Cash 4,00,000/-
