With due respect, I have the honour to state the following few lines that on 29th May 2023 at around 1:10 pm, Some Unknown persons suspected to be Kuki Militants open fired towards the Meitei Populace area of Kanto Sabal, Engourok Chingmang, and Leimakhong Chingmang and burnt/ vandalized many houses of Meitei community. In that, the said suspected to be Kuki Militants had trespass my house and looted The following items:-

1. Furniture Equipment:
 - a. Bent Saw – Rs. 1, 20,000/-.
 - b. Circular Bent Saw- Rs. 30,000/-
 - c. Electric Planner Rs. 24,000/-
 - d. Router- Rs. 24,000/-
 - e. Grinder- Rs. 8,100/-
 - f. Drilling M/c –Rs. 8,400/-
 - g. cutter M/C Rs. 6000/-
2. Washing Machine- Rs. 18,000/-
3. Kitchen items- Rs. 20,000/-
4. Cash – 4,00,000/-

Regarding the matter, I couldn't be able to register my F.I.R timely due to lake of legal knowledge. It is therefore, requested you to kindly take up necessary legal action.
