With due respect, I have the honour to state the following few lines that, I am resided at Kanto Sabal Awang Leikai which is under the control of Kuki militants. On 29th May 2023 at around 1:10 pm, Some Unknown persons suspected to be Kuki Militants open fired towards the Meitei Populace area of Kanto Sabal, Engourok Chingmang, and Leimakhong Chingmang and burnt/ vandalized many houses of Meitei community. In that, suspected to be Kuki Militants had trespass my house and looted several items as follows

1. Furniture items – Rs. 1,50,000/-
2. Washing Machine- Rs. 18,000/-
3. Television – Rs. 15,000/-
4. Refrigerator items – Rs. 20,000/-
5. Jeweler- Rs.50,000/-
6. Cash- Rs. 1,00,000/-
7. Rice- Rs. 20,000/-

Regarding the matter, I couldn't be able to register my F.I.R timely due to lake of legal knowledge. It is therefore, requested you to kindly take up necessary legal action.
