With due respect, I have the honour to state the following few lines that on 29th May 2023 at around 1:15 pm, Some Unknown persons suspected to be Kuki Militants opened fired towards the Meitei Populace area of Kanto Sabal, Engourok Chingmang, and Leimakhong Chingmang and burnt/ vandalized many houses of Meitei community. Due to fear of attack I along with my family members had fled away from my house. in that, the said suspected to be Kuki Militants had looted several items from my house such as domestic animals (6 ox, 3 cows, 1 calf), 50 ducks and cash (2lakh). The approximate value of looted properties is estimated around Rs. 5,90,000/- (Rupees five lakh and ninety thousand).

Regarding the matter, I wouldn't be able to register F.I.R timely due to lake of legal knowledge. It is therefore, requested you to kindly take up necessary legal action.
