With due respect, I have the honour to state the following few lines that, on 29th May 2023 at around 1:10 pm, Some Unknown persons suspected to be Kuki Militants open fired towards the Meitei Populace area of Kanto Sabal, Engourok Chingmang, and Leimakhong Chingmang and burnt/ vandalized many houses of Meitei community. Due to fear attack, I along with my family members had fled away from home after locked properly. In that, suspected to be Kuki Militants had trespass my house and looted my household properties i.e. Jewelry items, Cash (5.5 lakh), Cloths and kitchen items. The Approximate value of looted properties is estimated around Rs. 7,00,000/- (Rupees seven Lakh)

Regarding the matter, I couldn't be able to register my F.I.R timely due to lake of legal knowledge. It is therefore, requested you to kindly take up necegary legal action.
