Due to fear attack, I along with my family members had fled away from home. In that, suspected to be Kuki Militants had trespass my house and looted my household items i.e. Kitchen items, 50 nos. of ducks, jewelry, cash (3 Lakh). The approximate value of looted properties is estimated around Rs. 5,00,000/- (Rupees five Lakh)

Regarding the matter, I couldn't be able to register my F.I.R timely due to lake of legal knowledge. It is therefore, requested you to kindly take up necessary legal action.
