With due respect, I have the honour to report the following few lines that on 29th May, 2023 at around 1:10 pm, some unknown persons suspected to be Kuki militants open fired towards Meitei populace area of Engourok Chingmang, Kanto Sabal and vandalized many houses of Meitei. Due to fear of attack I along with my family members had fled away from home and taking shelter at Kanto Sabal Primary School Relief Camp. In that incident, the said unknown persons had looted several items as follows:

1. 5 no. of cows: Rs. 1,50,000/-
2. Cash: Rs. 2,00,000/-
3. Jewellery: Rs. 50,000/-
4. Clothes: Rs. 40,000/-

Regarding the matters I couldn't be able to report till date due to the present situation in the state. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
