Sir,

With due respect, I have the honour to state the following few lines that, I am resided at Leimakhong Chingmang which is under the control of Kuki arms militants since the beginning of the current ethnic violence in the State. On 7/5/2023 at around 7:00 pm, I had fled away from my home after proper locked and key due to fear & safety of our life.

However, on 1st September, 2023 at @ 10:00 am, many local women folk including local volunteers have visited at our respective shop for checking with the help of Indian Army. On checking it is found that, my shop many valuable properties i.e Sanitary items, Hardware items, electrical items, Barth fitting items and paint items etc. are also found missing which was suspected to be vandalized and looted by Kuki armed militants/miscreants in between 3rd May, 2023 to 31st August, 2023 after breaking the lock and key. The approximate value of the properties that were vandalized & looted is about Rs. 50,00,000 /- (Rs Fifty Lakh) approximately.

It is therefore requested you to kindly take up necessary legal action.
