Sir.

With due respect, I have the honour to state the following few lines that. I am resided at Leimakhong Chingmang which is under the control of Kuki arms militants since the beginning of the current ethnic violence in the State. On 4/5/2023, the tenant of my rented apartment informed me that they are fled away from my rented apartment due to fear & safely of their life. In this connection, I couldn't inspect my rented apartment due to present ethnic violence in the state.

However, on 3st September, 2023 at @ 10:00 am, many local women folk including local volunteers have visited at our respective houses for checking with the help of Indian Army. On checking it is found that, my rented apartment, many valuable properties i.e 3 phase Diesel Generator, one Mixer machine and 50 sacks of Paddy etc. are also found missing which was suspected to be vandalized and looted by Kuki armed militants/miscreants in between 3rd May, 2023 to 31st August, 2023 after breaking the lock and key. The approximate value of the properties that were vandalized & looted is about Rs. 4,80,000/- (Rupees Four Lakh eighty Thousand) approximately.

It is therefore requested you to kindly take up necessary legal action.
