With due respect, I, Moirangthem Kemichandra Singh have the honour to report the following few lines that I am residing at Awang Sekmai Khunou Leikai, Imphal West District, Manipur and I am the proprietor of M/s life Line pharamacy having Licence No. 3/QP-IW/2019 doing business at Leimakhong Chingmang, opposite Disha Gate Imphal West District, Manipur which is under the control of KUKI ARMS MILITANTS from the beginning of the current ethnic violence i.e from 3th May 2023. Due to the ongoing communal crisis between the two communities in the day of 29/7/2023 &30/7/2023, some unknown person suspected to be Kuki Militants holding sophisticated weapons looted my M/s Life Line Pharmacy located at Leimakhong Chingmang.

In that, the some unknown armed miscreants and Kuki had looted Pharmacy i.e Medicine/Injection and infusion I.V/I.M/ Surgical Items/Non Surgical Items/Medical Instruments and Equipment/furniture items/Refrigerators/Some Emergency Medicines/Electronic Items.

The approximate value of the properties that were looted is about Rs. 61,70,000/- (sixty-one lakhs Seventy Thousands only)

Regarding the matters, I could not be able to report timely to your good office due to the present ethnic communal violence in the state.

It is therefore, requested you to kindly take up necessary legal actions
