With due respect, I have the honour to state that, I am resided at Kanglatongbi Vijaynagar behind Hindi Govt. Hindi Sec School for last 17/18 years, which is under the control of Kuki arms militants since the beginning of the current ethnic violence in the State i.e starting from 3rd May, 2023. Due to threatening of life by unknown armed miscreants suspected to be Kuki militants, on 3/5/2023, I along with my whole family had escaped from my house for safety of our lives and presently taking shelter at Koirengei and couldn't return to my home till date due to present ethnic violence between two communities in the State.

Regarding the matter, I couldn't report timely to your good office due to lack of legal knowledge.
