With due respect, I the undersigned would like to lay down few lines before you
your kind consideration and necessary action.

On the 29th May, 2023 around 12PM, unknown miscreants belonging to the
Meitei community numbering more than 500 peoples suspected to be members
of Arambai Tenggol, Meitei Leepun and other have attacked my permanent
residence at Leimakhong Ex-Serviceman colony, Imphal West, Manipur by holding
deadly weapons including automatic rifles, swords, axes and bombs. The
miscreants have ransacked and burned down my house and all properties like
furnitures, kitchen items, clothing and other properties inside and outside the
house. The estimated value of properties lost, ransacked and burned by the
miscreants is estimated to be about Rs. 30,00,000 (Rs. 30. Lakhs).

I therefore request you to kindly take necessary action in this regards for we shall
remain ever thankful to you.
