Today i.e. 12/09/2022 at 5:20 pm received an information that on the same day at around 5:10 pm, one Tata Magic numberless driven by unknown driver proceeding toward Sekmai from Pheidinga side and one Bajaj Pulsar bearing Regn. No. MN04D 1095 ridden by unknown rider which was proceeding towards Imphal from Sekmai side collided each other at Pheidinga Lai Haraopham along NH-2, due to rash and negligent driving on the part of both unknown driver and rider. As a result of which the rider of the Bajaj Pulsar received injury on his person and immediately evacuated to Hospital for medical treatment as well as both the vehicles got damaged.

Hence a regular sou-motto case under FIR No. 341(9)2023 SEK-PS U/s 279/338/427 IPC has been registered for investigation.
