**Subject: Kidnapping of Mr. Md. Shah Rukh Khan, Engineer of M/s Keystone Infra Pvt. Ltd. from the campus of Tingri Lamkhai, PS-Sekmai.**

Dear Sir,

It is to report that 10 (Ten) including driver with full uniform of Manipur Police equipped with pistols and AK-47 came in 2 (two) white Gypsys. They were inquiring about a responsible person who can represent the company to sort out misunderstanding between them and the company.

They took photos of members present in the office and snatched mobile phones of all the members present and gave phone no. bearing 8011189793 to contact with their higher up. The list of mobile phones snatched owners are enclosed as **Annexure-I**. They wanted to kidnap Mr. Ranjit Kumar Mohanty also but on denial of Mr. Mohanty to leave the office without the information of higher officials, he was beaten and dragged to load to their gypsy. But, later on we have been informed by our higher officials as they are fake Manipur police personnels. they have carried away our 1 (One) Engineer by the name Md. Shah Rukh Khan, Lilong Haoreibi, Turel Ahanbi to clear the doubts between the company and them regarding ransom. The incident took place at about 4:58 PM within the office of M/s Keystone Infra Pvt. Ltd.
