

Later, it came to our knowledge that the looting of properties is done by one Masud Hasan @ Anwar of West Bengal Bada Nurapur Paschimpara, P.O. 742223 who is staying at a rent house of one Paocha 41 yrs of Ex-Serviceman colony. In this regard, we had warned him to stop such act, However he still continuing looting of private properties belongs to the displace families and the Government properties taking advantage of the present situation. We the members of club have started surveillance over him and his men, today i.e. 08/10/2023 at @ 4:50 pm 7 persons in a Tata truck B/Regd. No. AS01N/9226 are caught at Kanto Awang Leikai along with the properties of the victim families and equipment of power Generation side.

Hence, I am handing over the attested persons and the stolen materials to you for taking up necessary legal action.
