

With due respect and humble submission, I beg to state that my vehicle viz. Tata 4 by 4 TC bearing regn. No.MN07C-3140 has been kept at a workshop for repairing at Pheidinga on the 1<sup>st</sup> of May, 2023. However when enquired the process of repairing on 01-10-2023, it was learnt that all the parts of my vehicle has been robbed off and dismantled leaving the only body in a condemned state by unknown miscreants suspected to be from the Meitei community. The person in charge of the Vehicle workshop is identified as Sobha (Contact No. 8415922744).

I could not report the matter to the concern Police Station due to the prevailing law and order situation in the state.

I, therefore request you to kindly register the case and take necessary action according to law.
