

With respect and regards, I have the honour to report the following few lines that today i.e. 27th October 2023 at around 6:20 am, I have left Imphal for Guhawati on a Winger, passenger vehicle. On the same day at around 8:00 am while reaching at Awang Sekmai Nongthonband near LNC & Sons Filling Station along NH-2, our vehicle was stop forcefully by some unknown persons numbering about 5/6 persons who were coming in a car red in colour and they forcibly boarded me on their car and took me to some places which is unknown to me. Later, the unknown persons forcefully took one gold Bangle weight about 120 grams from my possession. After that, they drove me at the place where they have picked me up.

It is therefore, requested you to kindly take up necessary action against the culprits.
