Sir,

As per endorsement, I have conducted a concrete enquiry in c/w the above cited UD Case. On enquiry, I have conducted a spot inspection, in that found the dead body of Late Maibam Shakhenbi Devi covered by a white cloth, lying over a plastic mat at the verandah of the deceased house. Also inspected the place i.e. Lai ingkhol, located at 200/300 meters far from the house of deceased where she found lying unconscious very carefully and minutely. A rough sketch map of the PO is drawn with its proper indexes. An inquest is also conducted over the dead body. Post Mortem examination was conducted over the dead body in presence of Mairembam Saileshraj, SDC Sekmai/EM-IW with video coverage vide Additional District Magistrate, Imphal West District order No. DM(IW)/1/398/I & PME/CON/04(pt) dated 4th October 2023. The required items for ascertaining the cause of death were seized before the witnesses on production by of Dr. Soibam Neha, Senior Resident, Department of Forensic Medicine and Toxicology, RIMS. One recorded pack and sealed TDK MINI DV Cassette was also seized in presence of witnesses on production by of Thiyam Somen singh (59) S/O (L) Th. Ibona Singh of Tera Lukram Leirak. Report of Post Mortem examination is still awaited.

During the course of enquiry, examined a good number of witnesses who are relatives and neighboring of the deceased. Examined the complainant, cousin brother of the deceased and he stated and he had learnt that she had love affairs with one Muslim boy since 2/3 years back, which she wanted to break-up since they belongs to different communities.

On examination of Waikhom (O) Ibemcha Devi (50) yrs w/o W. Sunil Sing of Loitang Khullen, aunty of the deceased stated that since 2<sup>nd</sup> October 2023, some unknown number called her frequently at odd hours that makes nuisance in her family but when she pick up the called did not respond anything. Later it is learnt that the unknown number is the number of the deceased's boyfriend.

On examination of Maibam Anjali Devi (26) yrs d/o M. Tomba Singh of Loitang Khullen Awang Leikai, cousin sister of the deceased stated that Syed Asim Nurul started to called several times from different mobile number and force her to help in re-building the relation between him and the deceased. Further Syed Asim Nurul threatens her stating that his mother was died due to break up of their relation and the responsibility will be given to the deceased and her family. Syed Asim Nurul sent many text messages from different mobile numbers which causes so many nuisances among the family members and hurt the reputation of the family in the society.

On examination of Senjam Tombi Devi (62) yrs W/o Senjam Ingocha Singh of Loitang Khullen Awang Leikai, aunty (Mamabok) of the deceased stated that Syed Nurul Asim give threat calls by saying that "Noi Loina Nongmeina Kapura Noi Loina Hatok-ura.

On examination Angom Ichal Devi (26) yrs W/o Angom Sunil Singh of Phayeng, elder sister of deceased stated that the deceased is quite close to her and she used to share all her problems. So, she had known that Syed Asim Nurul had made threat to her sister on being rejection to their love affairs and he also threaten her on mobile phones with dire consequences if she did not help in rebuilding the love relationship.

On examination of Maibam ongbi Thoithoibi Devi (50) yrs W/O (L) M. Nanao Singh of Loitang Khullen Awang Leikai, mother of deceased stated that her daughter had love affair with a Muslim namely Sayed Asim Nurul since 2021 while she was studying class X at Standard English School, Khurkhul. Due to difference in community and caste her daughter tried to stop their affairs since five months and she did not responds to any calls of Sayed Asim Nurul and kept the mobile number at blacklist. In the year 2022, her daughter went to standard school for taking certificate, in that the boy Syed Asim Nurul beat her on face, eyebrow which causes a bruise and green marks.

On examination of Maibam Nanao singh (50) yrs S/O (L) M. Binomadhop Singh of Loitang Khullen Awang Leikai, father of deceased stated that his daughter had love affair with a Muslim namely Sayed Asim Nurul since she was studying class X at Standard English School, Khurkhul. Due to difference in community and caste his daughter tried to stop their affairs since five months. She did not respond to any calls of Sayed Asim Nurul and kept mobile number at blacklist. His daughter tired hard to stop their relation but the boy Sayed Asim Nurul refuge his daughter's proposal. In spite he started to threaten his daughter as well as his family members, relatives and neighboring. On 28th September 2023 one unknown person called him and identified himself as Sayed Asim Nurul's elder brother and threaten him that "HENBI GA EIGI ENAONUPA SAYED ASIM NURUL GA NUNGSHINABADU HENBI NA TOKNARASE HAIRAK-A, ADU HAIRAKPADAGI SAYED ASIM NURUL HOO THAK-A, KIDNEY ANIMAK DAMAGE OIRE, HOUJIK COMA DA LEIRE, MAGI MAMASU HEART PATIENT NI ADUNA MARAM OIRAGA MAMASU NARE, SAYED ASIM NURUL HAYENG GUHAWATI DA PURANI, APHA-PHATA THOUDOK THOK ADI NOINA DEITA PUGADABANI". Even though he identified himself as Sayed Asim Nurul's elder brother, he knows the person was Sayed Asim Nurul from his voice. From that day onwards Sayed Asim Nurul called and sent text massages frequently from different numbers. He also called on many mobile numbers of his neighboring which hurt his reputation in the society as well as hurt the modesty of his daughter.

In the meantime, on 9/10/2023 received an anticipatory bail coupled with adinterim relief of the accused person Syed Asim Nurul from Hon'ble Court of session Judge with a direction to summit call bail/status report. On 18/10/2023 submitted the same to the concerned court. Later, on 25/10/2023 the interim relief provided to the accused person Syed Asim Nurul is vacated by an order of Hon'ble Court of Session Judge, Imphal West vide order No. Cril Misc. (AB) Case No. 70 of 2023 dated 26/10/2023.

The enquiry so far conducted reveals that, Syed Asim Nurul aged about 22 years S/O Syed Nurul Azim of Kshetri Bengoon awang Leikai PO/PS- Porompat, Imphal East District threaten to the live of Late Maibam Shakhenbi Devi and her family members, relatives, near and dear ones and neighborings.

Such act of Syed Asim Nurul sense a lot of shame and feels bashfulness which hurts the moral modesty of late Maibam Shakhenbi Devi as well as gives a great threat to her innate sense of self respect and dignity, a psychological modesty. Those situations and threats abet late Maibam Shakhenbi Devi to commission of suicide and she committed suicide on 4/10/2023 at around 7:00 am.

From the above facts and circumstances, I therefore prayed to convert the UD case into regular FIR under 354/306 IPC
