







Sir,

I have the honour to report that, today i.e. 12/11/2023 at around 1:35 am, I was informed by driver namely Sanjiv Kumar Thapa (35yrs) S/O. Gopal Thapa of Kanglatongbi Tispari who is carrying my vegetable i.e. Rajma, chack hawai, hawaimubi, Sendrang maru, hawai trak from Dust Mile, Thonglanag Chawangkine IT road, Kangpokpi towards Imphal along with Mahindra Super bearing no. MN01AA-3353. That, on 11/11/2023 at @ 08:30 pm, on reaching Kanglatongbi Makhan crossing while the vegetable was sifted (paltai) to three diesel Auto bearing registration No. (1) MN01AF-7736 (2) MN01AD-3246 and (3) MN04G-2205 due to overloaded. In the meantime some unknown persons numbering about 12-13 persons coming with two Gypsy white in colour without registration number have kidnapped them at Kanglatongbi Makhan Crossing and took them to unknown places, Later on the vegetables was transferred to another three vehicles i.e. (1) Bolero Pick up white in colour (2) Tata Axe white in colour (3) Gypsy white in colour bearing registration not Known and they were detained at that unknown place till 1:30 am of 12/11/2023. During their detention they were assaulted by the Unknown persons. The approximate value of said vegetables is about Rs.1.8 lakhs (Rupees one lakh eighty thousand).

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
