

With due respect, I would like to inform you that on 3rd May 2023 at around 4:00 pm some valley-based organisations suspected to be volunteers of Arambai Tenggol, Kangleipak Kanba Lup (KKL), Meitei Leepun, stopped me at Maharabi near Sekmai while on my way back to Motbung from Imphal. They verify me and asked me for my Adhar Card. After they came to know that I am a Kuki they took my vehicle aside and burnt it down while I managed to escape from the site and reached Motbung in the evening. I purchased my 2-wheeler vehicle (Grazia Disc, Rose White Repsoled) bearing Registration No. MN01AM-6414, Chassis Number ME4JF997JNW004985 and Engine number JF99EW0147648 through loan from Honda Punya, Chingmeirong Imphal and its registration was done in my name Lamhoichong Lhouvum.

I therefore request you to take up necessary legal action regarding the incident.
