With due respect, I have the honour to report the following few lines that on 3rd May, 2023 at around 7:30 pm, large number of unruly mob suspected to be Kuki tribe community armed with deadly weapons like stick, dao, fire arms etc. had trespass and burned down house of W. Sunil Singh S/o (L) W. Dhananjoy Singh which is my uncle residing at Kanglatongbi Shantipur near Gamgiphai. In that, the unruly mob had completely burned down my 4 wheeler Maruti Eeco van which was kept at my uncle bearing registration no. MN03A/3898 having MA3ERLF1S00614170, Engine no. G12BN592261 Silver in colour all the related documents of the vehicle were inside the vehicle. The approximate value of burned down vehicle is estimated at Rs. 500000/- (Rupees Five lakhs) approximately.

Regarding the matters I couldn't report in time due to lack of legal knowledge. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
