

Sir,

I have the honour to report that on the late evening of 3rd July, 2023 at around 5:00 Pm, my village Khongnangpokpi, Kangpokpi District was attacked by unknown miscreants suspected to be Arambai Tenggol, K.K.L., Meetei Leepun fully armed and dressed in IRB & Commando uniform. The miscreants forcefully broke into my house & vandalised all my properties & looted valuable items i.e, Gold, cash & Alto Car.

The approximate value of loss & Looted/Destroyed properties is estimated to be about Rs 18 Lakhs including Domestic animals (7 cow, 15 Pig & 10 Goat).

I, therefore request you to take necessary action according to law.
