The miscreants forcefully broke into my house & vandalised all my properties & looted valuable items i.e, Gold, cash & Alto Car.

The approximate value of loss & Looted/Destroyed properties is estimated to be about Rs 18 Lakhs including Domestic animals (7 cow, 15 Pig & 10 Goat).
