Subject: - Report.

Sir,

I have the honour to state that today i.e. 08/12/2023 at about 12:30 pm, received a reliable information about the presence of some active cadres of PLA/RPF an outlawed banned organization in and around Thangal Bazar area with a view to commit prejudicial activities like extortion of money from the general public etc. Acting on the information, teams of CDO-IW led by Inspector P. Achouba Meetei, OC-CDO-IW, and myself under the command of Shri M. Amit Singh, MPS AddLSP(Ops.) IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW, rushed to the said area and conducted cordon and search operation at Kasturi, Thangal Bazar. During that one unknown person was found standing near one NV Vespa black in colour bearing registration no. MN1J 4129 in a very suspicious manner in front of Naman Store, Thangal Bazar. Due to his suspicious nature, he was detained for spot verification and checking. On spot body searched 2 (two) mobile handset i.e. (i) one CELLECOR X2 mobile handset along with one Vodafone SIM card bearing SIM no. 8991755261074668846SY (Phone No. 9774467138 as disclosed by him). (ii) one Realme 7i mobile handset along with one Jio SIM card bearing SIM no. 89918650400013768611 (Phone No. 7005920250 as disclosed by him), a sum of Rs. 10,000/- (rupees ten thousand only) from the right side pocket of his jacket, one wallet black in colour containing one Aadhaar card and a sum of Rs. 3000/- (rupees three thousand only) were recovered from his possession.

On spot verification, he identified himself as Laishram Lakshmikanta Singh @ Toni (44 yrs.) S/o. (L) L. Deben Singh of Kwakeithel Moirang Purrel. On preliminary questioning, he disclosed that he is an active member of PLA/RPF organization and started working for the said organisation since 1998 under the command of s/s Commander Somi (8131070545/9362664460) of PLA/RPF organisation from Khurai area. He disclosed that under the instruction of his commander, he made monetary demands from many shopkeepers located at Paona and Thangal Bazar, earlier he also extorted huge amounts of money from several businessmen, shops and general public in and around Imphal area for their party fund and the extorted money were handed over to his commander. He further disclosed that the above recovered amount of money i.e. Rs. 10,000/- was extorted today from general public for their party fund and the above mentioned NV Vespa black in colour was used in their party activities.

Hence, he was arrested at the spot at 01:00 pm and the above mentioned recovered articles along with the above mentioned NV Vespa black in colour bearing registration no. MN1J 4129 were seized at 01:20 pm by observing formalities.

It is, therefore, the arrested person and seized articles are handed over to you for taking further necessary legal action against him.
