



**Subject: Arson Reports.**

Dear Sir,

I, Paogin Haokip age about 54 years S/O (L) Ngamthong a resident of Saiton Khunou P.O. Moirang, P.S. Churachandpur, District Churachandpur presently staying at B.Aijalon, Tuibuong Churachandpur, P.O.& P.S. Churachandpur. Would like to report that, due to the communal violence a group of Meitei miscreant attacked our village on the 4<sup>th</sup> day of May 2023 at around 6:00 pm who started to burn our house fearing for the safety of our own house I fled toward Tuibuong leaving behind our property which ultimately burnt to ashes. The total value of loss in this arson is estimated at Rs.4,000,000/-(Rupees Forty Lakhs) which include of Semi-Pucca House, Household electronic item, Furniture, Kitchen ware etc,

I, Therefore would like to request your office to look into the matter and initiate necessary action at the earliest for the end of justice.

For which kind act of yours I will remain thankful to you.
