I, Thongkholun Lhungdim age about 54 years S/O (L) Chungthang Lhungdim a resident of B.Aijalon, Tuibuong Churachandpur, P.O.& P.S. Churachandpur would like to report that I am the proprietor of Poultry Farm at Saiton Khunou P.O. Moirang, P.S. Churachandpur, District Churachandpur where about 6,000 (Six Thousand) chicken were raise since 2021. That, due to the communal violence we have fled toward Tuibuong on the night of 3/5/2023 and the farm was left unattended whereby on the 4th of May 2023 at around 2:00 pm the Meitei from the area started to loot and vandalized my farm before setting fire to it which completely burn down my whole farm total loss of property in this arson is estimated to be at a value of Rs.4,500,000/- (Rupees Forty Five Lakhs only).

I, Therefore would like to request your office to look into the matter and initiate necessary action at the earliest for the end of justice.

For which kind act of yours I will remain thankful to you.
