With reference to the above cited subject, I have the  
honour to report to you as below:

1. That, I, Thangpu Quite 57 Years, H/O Themneining  
Quite belongs to the Kuki Community. By virtue of  
which, I am entitled for protection under the SC/ST  
Prevention of Atrocities Act, 1978.
2. That, I am a permanent resident of pholjang Munrom,  
P/S Churachandpur, District Churachandpur. My village  
being one of the frontline villages became volatile and  
unsafe due to the incessant attacks from the Meiteis.  
Wherefore, I, along with my wife deserted/left the  
village for safety on June 12<sup>th</sup> 8 AM, 2023. Since  
then, I have been residing at Tuibong (Rent) Cpur.  
I managed to keep safe my properties at the  
residence of my friend Mr Riza Epham of Kwakta  
Ward VIII.
3. That, on 5<sup>th</sup> August 12 Noon, radicalised Arambai  
Tengol and Manipur Commando bombed my  
properties to ashes. Total worth of my properties  
= Rs. 5,00,000.
