

That on 04-05-2023, at about 5:00 pm, some unknown persons numbering about
423 belonging to KUKI community started attacking the undersigned along with family members.
Thereafter, the KUKI people started destroyed and burning the house of the undersigned resulting in
all the properties of the undersigned were razed to the ground and all the belongings and jewelleryes
were also burned/destroyed/stolen before burning/damage.

In the said incident _____ was badly injured due to pelting of
stones/hacking with knife/ shot form firearms toward us by the miscreants.


A separate sheet showing the particulars of all the losses incurred by me is attached along


