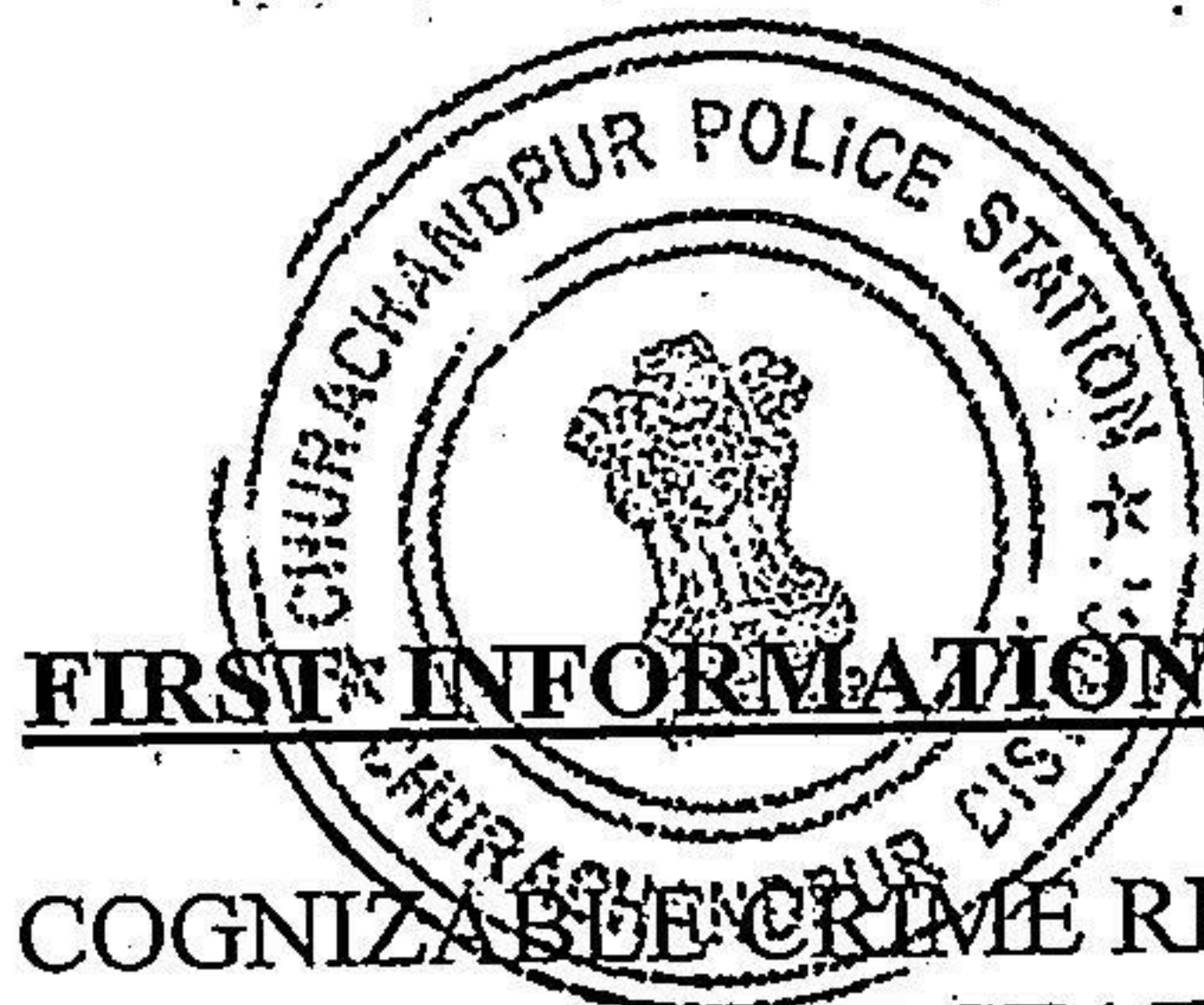

I the undersigned beg to report for your kind and necessary action. That, I and my family are victim of the present unrest that occurred from 3-05-23 onwards,

That on 3-05-23 at around 7:30 Pm. while I was at home, some unknown armed miscreants attacked our locality. Burnt down our houses and destroyed our house hold properties worth around 58 lakhs (Fifty eight lakhs).

The miscreants suspected to be the Kuki tribe which burnt down my residential house, 2-wheeler private Vehicle and other household items.

Delay of Filing a F.I.R. is due to displacement and uncertainty of place.
