That, I am a Scheduled Tribe belonging to the Paite Tribe, which is a recognized Tribe under the Constitution of India.

That, on the 4th of May, 2023, at about 7:30 PM, my 2(Two) houses located at Mata Village (near Leisang Bridge), P.O., P.S. & District- Churachandpur, which I gave it on rent to 3(Three) families, namely a) Mr.Santy (63), b) Mr.Naubi (40) and c) I Bungcha (39) and their contact details-9862246094, belonging to the Meeitei/Meitei community along with my Granary (60 rice bags) was destroyed and burnt by an angry-mob, which is estimated to be worth Rs.30,90,000/- (Rupees Thirty Lakhs Ninety Thousand) Only, which occurred due to the ethnic crisis.

Therefore, the report couldn't be made on time due to the Law and Order situation in the State, so, I humbly pray you to kindly register a FIR and investigate the matter as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
