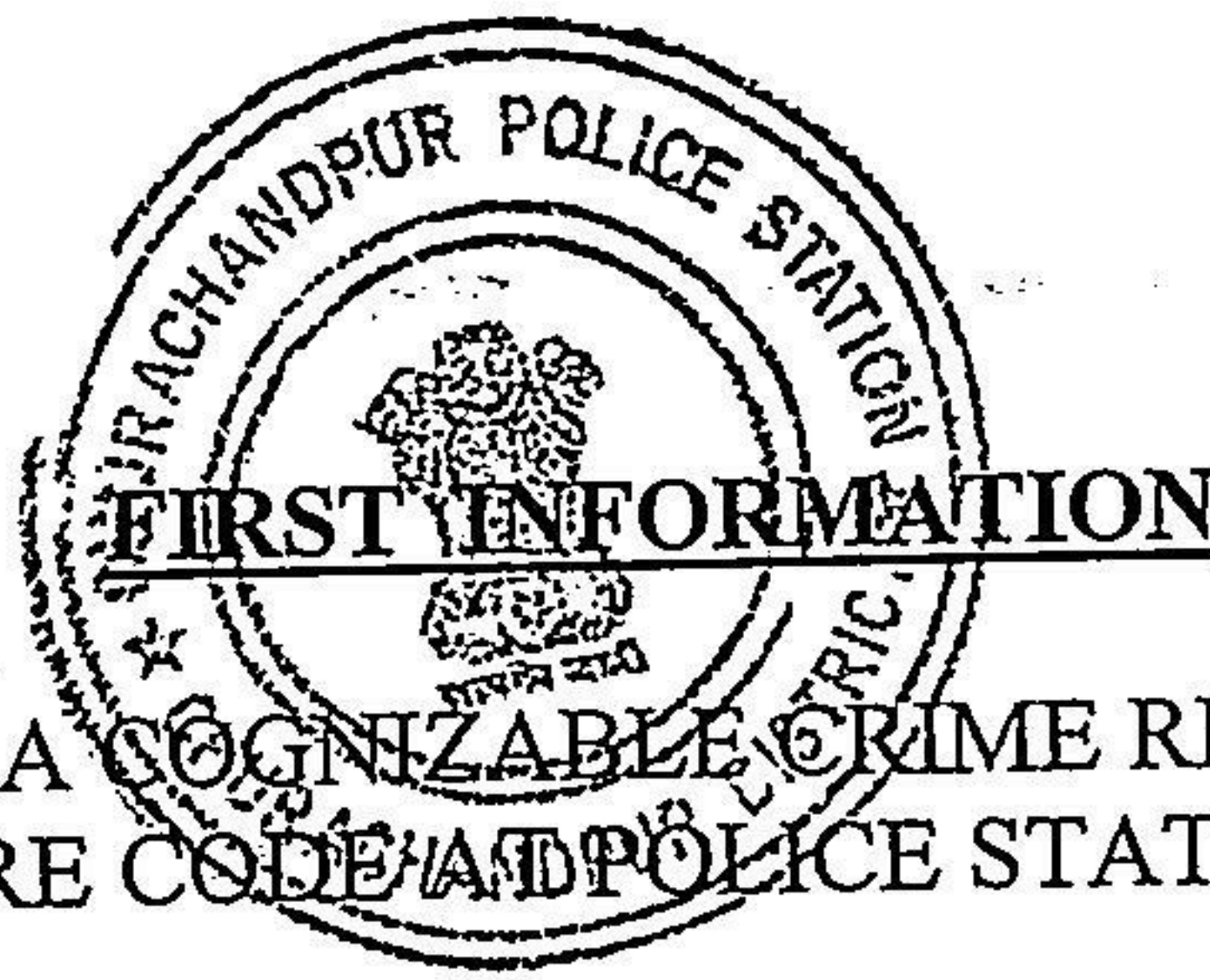

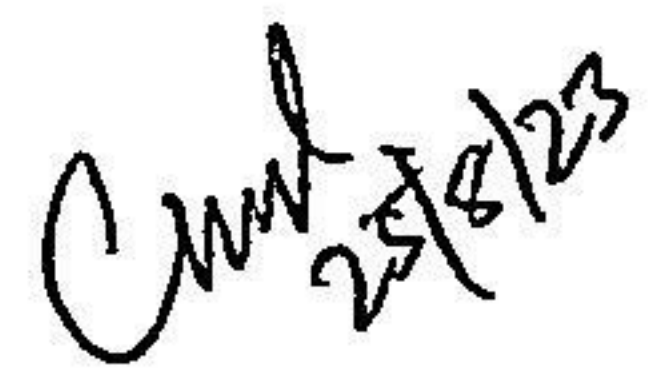

Respected Sir,

I, the undersigned beg to report for your kind and necessary action.

1. That, on 04/05/2023 at around 11.30 a.m./p.m., some unknown miscreants suspected to be Kuki Militants/Kuki Tribes rushed to our locality with arms/sophisticated weapons and open fired indiscriminately. They have destroyed/burned down the Temple (Laishang) of FAMILY APOKPA which is located at North Eastern part of my residence along with Hall and other annexed buildings.
2. That, the properties damaged/destroyed by the miscreants is about Rs. 1,97,800/- (Rupees One Lakh Ninety Seven Thousand Eight hundred) approximately.
3. That, I could not report well in time due to the prevailing law & order situation as well as we were displaced and stranded. I am taking shelter at THANGJING SINDAM SHANGLIN, MOIRANG since along with my family members till date.

It is therefore, requested to take up necessary action in accordance with law against the unknown miscreants suspected to be Kuki Militants and Kuki tribes.

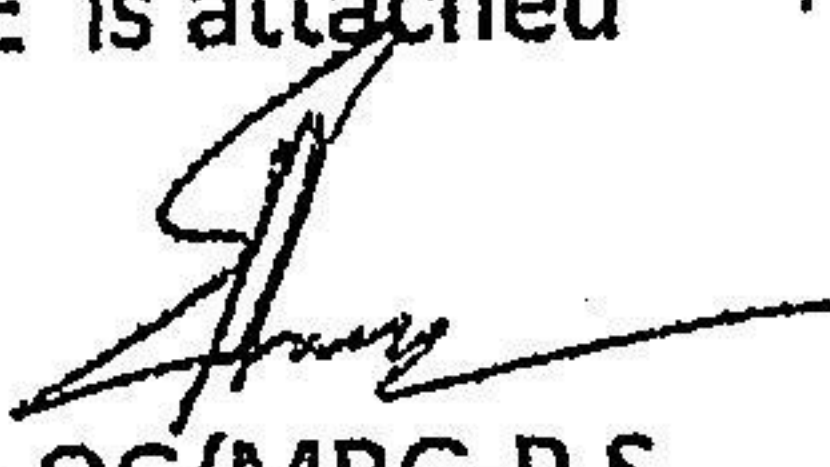
