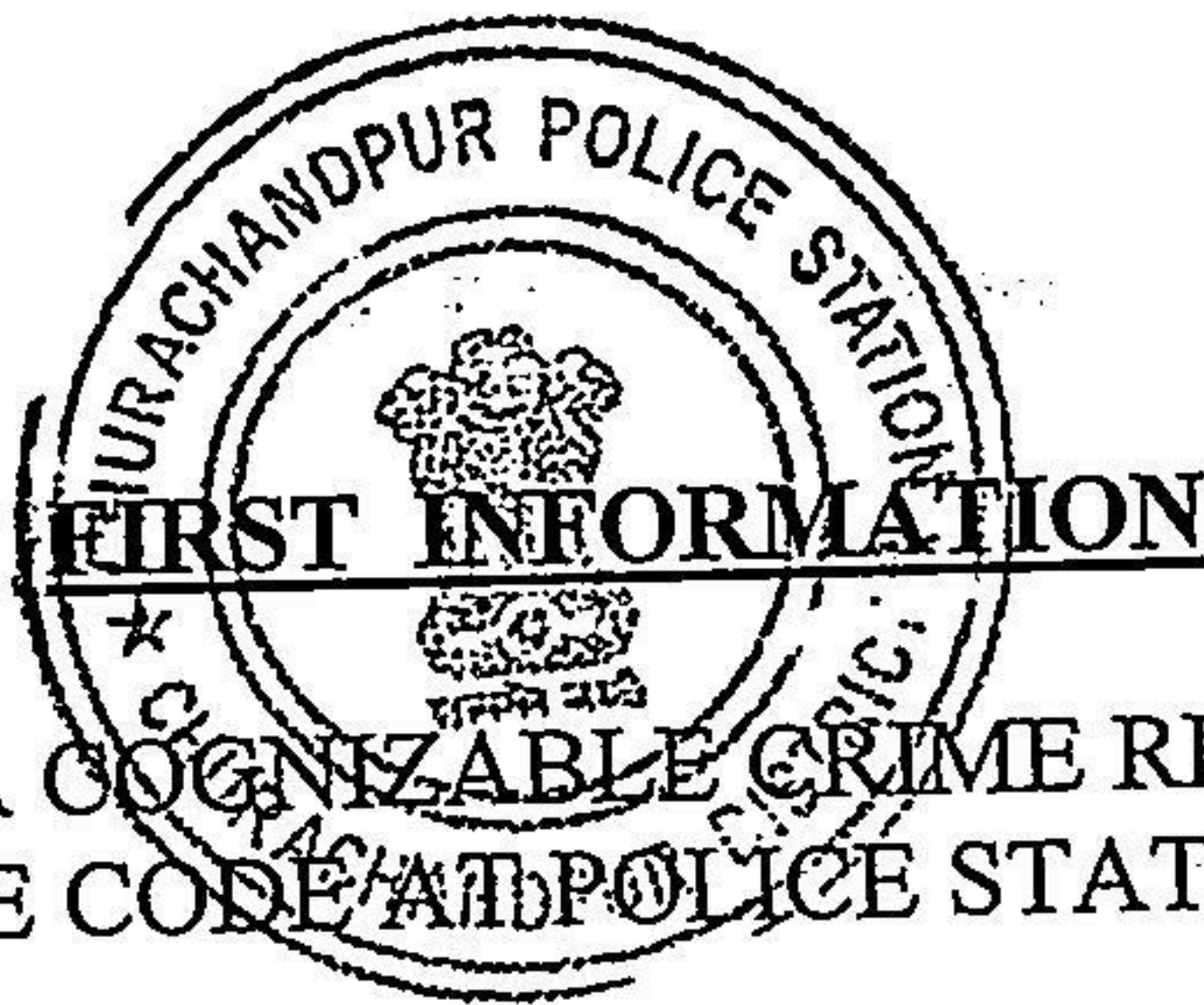

I, the undersigned beg to report for your kind and necessary action.

1. That, on 4th May 2023 at around 7:30 a.m./p.m., some unknown miscreants suspected to be Kuki Militants/Kuki Tribes rushed to our locality with arms/sophisticated weapons and open fired indiscriminately. They have destroyed/burned down the Temple (Laishang) of NONGPOK NINGTHOU PANTHOIBE which is located at Khuga Tampak Meeki Leikai along with Hall and other annexed buildings.
2. That, the properties damaged/destroyed by the miscreants is about Rs. 60,000 (Rupees Sixty Thousand Rupees) approximately.

3. That, I could not report well in time due to the prevailing law & order situation as well as we were displaced and stranded. I am taking shelter at Thangjing Sindam Shanglen Relief Camp since 4th May 2023 along with my family members till date.

It is therefore, requested to take up necessary action in accordance with law against the unknown miscreants suspected to be Kuki Militants and Kuki tribes.

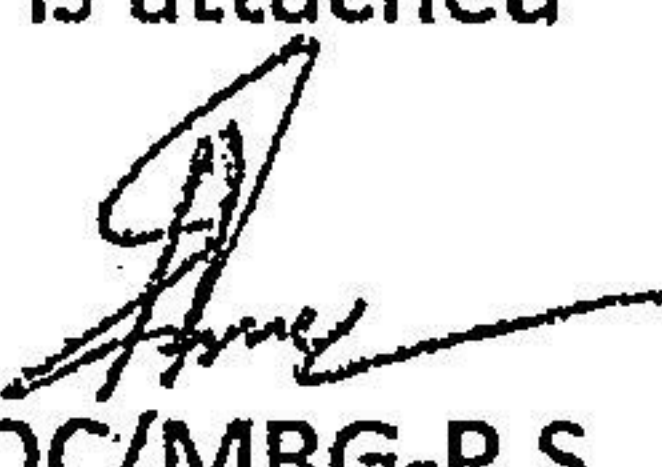
