Sub: **Report of criminal intimidation, un-lawful displacement, unlawful occupation and looting.**

Sir/Madam,

I, Shri Thangkhopao Lhungdim, aged about ²⁹22 Years, S/o (L) Jamkhongam, would like to bring to your good office on following facts and circumstances that;

1. That, I am presently serving as a Chowkidar (Contractual) at Regional Institute of Medical Sciences (RIMS), Imphal, occupying Quarter No. Type V/59 situated at the RIMS Campus, P.O. & P.S. Lamphel, Dist. Imphal West, Manipur-795004.
2. That, I along with my family was forced to leave my Quarter which is situated at the RIMS premises on the 4th May, 2023, due to the ethnic conflict prevailing between two community within the State of Manipur. It may be pertinent to mention here that we had to run for our life on the abovementioned date when some armed miscreants suspected to be the members of Arambai Tengol and Meitei Leepun belonging to the meitei/meitei community start targeting the Zo ethnic tribals (Kuki-Zomi-Hmar) by entering their locality and burning down their properties, killing, looting and launching an organised man hunt upon them (to the Zo ethnic Tribas) within the Imphal Valley.
3. That, during the early period of this month i.e. July, 2023, it is heard from reliable sources that **there is an unauthorised occupation** of my abovementioned quarter thereby the whereabouts of my household properties **including movable/immovable properties** are unknown. As of now, i am presently taking shelter at Greenwood Relief Camp, B. Vengnom, Tuibong, Churachandpur, Manipur, which is a relief centre meant for displaced peoples due to the present ethnic conflict.

In the light of the above facts and circumstances, i humbly request your good office with folded hands to kindly take strong actions by registering a ZERO FIR, initiate an investigation and book the culprit/perpetrator(s) according to the law of the land.


