Dear Madam,

I. NEJAHEMAK)

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the Vaiphei Tribe, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under the SC/ST (Prevention of Atrocities) Act, 1989.

That, due to the prevailing ethnic crisis in and around Imphal, I along with my family left our residential quarter at Qtr. No. 30/11/324-NPHC (LPL), P.O./P.S Lamphel, District- Imphal West-795004 on the 4th of May, 2023 at around 9:30 AM, And, it has come to our knowledge that our deserted quarter was attacked, destroyed and looted by a Group of radical Meeitei/Meiteis suspected to be members of Arambai Tengol and Meetei Leepun on the 26th of July, 2023 at around 9:30 PM.

The criminals broke open my door, destroyed and looted every valuable property from my residential quarter including my commercial vehicle (diesel-auto) registered under the name of my husband @ Th Lamkhokam Vaiphei bearing regn. No. MN01 C 0420, worth about Rs. 12,50,000/-(Rupees Twelve Lakhs Fifty Thousand) only.

That, it may be reported here that the miscreants were shouting slogans in Meeitei/Meiteis language like-"LONG LIVE MEEITEI/MEITEIS LAND"; "KILL THE KUKIS"; "KILL THE SON' & DAUGHTER' OF THE KUKI TRIBES"; etc. while they were carrying out their criminal activities. It seems to me that all these has taken place at the instance of the Manipur State Government as the perpetrators openly claimed and shouted that nobody would stop them, even the police because

everyone, including top officials of the Manipur Government are patronizing them and that that no harm could be done to them.

I, therefore, request you to kindly register my case as ZERO FIR and take stern action against the perpetrators under the relevant provisions of the law of our country.


