And i strongly condemn for their act of breaking and looting of my properties and i earnestly appeal to the Government of Manipur to compensate of my lost & broken properties and renter's worth are mentioned below.

- 1. Pucca residential building broken worth of Rs. 37,00,000 (Thirty seven lakhs) only
- 2. Properties looted worth of Rs. 45,00,000 (Forty five lakhs) only.
- 3.Two wheeler(Activa Honda) grey colour MN 01AL7936 stolen worth of Rs. 95,000 (Ninety five thousand) only.
- 4. Cash stolen of Rs. 2,00,000 (Two lakhs) only.
- 5. Renter's properties destroyed worth of Rs.22,00,000(Twenty two lakhs) only.
- 6. Renter's Properties looted worth of Rs. 17,00,000 (Seventeen lakhs) only.
- 7. Renter's two wheeler (Apache) red colour MN01D8683 stolen worth of Rs. 98,000 (Ninety eight thousand) only.
