I hereby inform that on 04-05-2023 at around 3:00 am, during the ethnic problem, some unknown mob broke my gate and entered forcefully into my rented house (House owner namely Seitinmang Kipgen) at Khongsai Veng (Laipham Khunou), Imphal East, Manipur. The unknown mob destroyed the properties, took away the valuable properties including two wheeler PLEASURE+ZX+ B/R No. MN01AL-3203. Finally burnt down all the remaining properties. Fortunately our family escaped unhurt for our livelihood. Due to the present prevailing Ethnic problem in the state, the matter could be able to report in time.

The following items were destroyed and took away as listed below:

(1) Mattress 2 nos (2) Shoes rack-1 no. (3) Book rack-1 no. (4) Wooden Almirah-1 no. (5) Plastic drawer- 3 nos (6) Bed-2 nos (7) Table-2 nos (8) Syntex- 1 no. Total approximate value of the property is Rs. 3,00,000 (Rupees Three Lakh only)
