



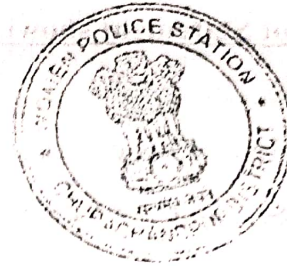

Sir,

I, the undersigned would like to bring forth to your knowledge and report that I, am a permanent resident and native of *Spring Villa, Phaipijang, Langol* Village, P.O.&P.S. *Langol Super Market* District. *Imphal West* Manipur and that because of the ethnic conflict prevalent in the State, some unknown well-armed miscreant belonging to the meitei/meitei community on being targeting our village and its villagers to gutted down our houses and bodily harm the people to the extent of death, with no means of defence and security from the State's Government leaving us hapless, on being feared for our life, deserted our village on *4th May 2023* at *10.00* a.m. / p.m., leaving behind all our assets and home, a total estimated at an amount of Rs. *57,85,000/-* was left behind at the mercy of the above mentioned well armed meitei/meitei miscreant and now currently resides at *R/C Lane, Salem Veng, Lamka*.

Therefore, I kindly request you to please act in this matter and come up with positive solution.
