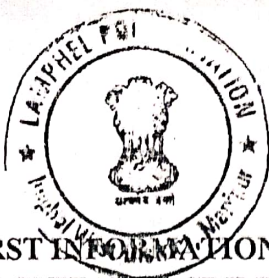


With due regard and respect, I the undersigned would like to state few lines for your kind consideration and needful action.

That today i.e. 31/8/2023 at around 5.00 pm, some unknown miscreants consisting of male and female numbering about 200/300 had gathered the ambulance vehicle near the RIMS Hospital Mortuary, Lamphelpat which carried the dead bodies of two deceased persons namely Pebam Devan Singh, 54 yrs S/o Late. P. Ibochouba alias Thangsuba Singh of Thamnepokpi Makha Leikai near Bazar, Bishenpur District and Moirangthem Ropen Singh, 44 yrs S/o M. Commander Singh of Yorabung Mamang Leikai A/P Etham Nungoi, Imphal East District, Manipur in c/w FIR. No. 1509(8)2023 MRG-PS u/s 400/447/307/326/34-IPC & 25 (I-B) A. Act & Sec. 3&4 of Expl. Sub. Act r/w 302-IPC and obstruct us while performing our duty for depositing the dead bodies at RIMS Mortuary as well as tried to snatch our mobile phones for not to contact higher authority. However, I had informed the incident to SP-BPR Control about the matter for getting re-enforcement. Thereafter, the dead bodies were forcibly taken away by them on a mini Tata Super AC, Grey Colour in order disappeared the evidence of the case.

Therefore, I request you to kindly take necessary action against the unknown miscreants for their wild act. Thanking You.
