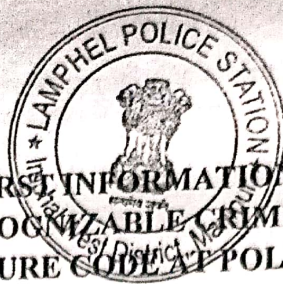





Lamphel District Imphal West Manipur and that some armed radicals belonging to the Meetei/Meitei community broke open my rented/residential home and vandalized, looted and gutted/burnt down and all what is within and along with the house was lost to the said meetei/meitei armed radical groups illegal activities a total loss estimated to be at an amount of Rs. 6,11,000/- Only. on 4/5/2023 at around 5:00 pm.

Fortunately, me and my family managed to escaped from these criminals who even tried to kill or burn us alive, and now currently taking refuge at Immanuel Khopi, CCPU, Manipur.

Therefore I kindly request you to please take action in this matter and come up with positive solution.
