That on the 15th Day of August 2023 at around 2:00pm local Meire Paibi from the vicinity vandalized and looted our quarter at the mention address thereby causing a loss estimated to be at a value of about Rs.3,400,000/-(Rupees Thirty four Lakhs only). (Copy of property detail attached)

I therefore, would like to request your kind office to take necessary action at the earliest so that the culprit of this heinous crime may be booked under the provision of law.
