August 18, 2023, and request for filing Zero FIR in that regard.

Respected Sir,

This is to inform you that my rented room/accommodation on the
Second Floor of House No. 88, Lamphel Supermarket (PDA Complex),
PO/PS-Lamphel, District-Imphal West, Manipur, was torched by some
unknown miscreants (numbering about 50 as per eyewitness sources who
wish not to be identified) at around 1200 hrs on 18.08.2023. The house is
owned by one Tongkhohao Baite, s/o Thangso Baite (ex-MP, Manipur), r/o
Langol, Imphal West district. As a result, all of my household belongings,
worth about Rs. 6,36,222/- (Rupees six lakh thirty six thousand, two hundred
twenty two) have been gutted in the fire. A list of the household goods burnt
in the fire along with their approximate corresponding values is enclosed for
necessary action.

I, therefore, request you to kindly register a Zero FIR) at Kohima South
PS) and initiate further necessary action in this regard for the ends of justice.
