Sir,

I have the honour to state that, on 3-05-2023 at around 06:30 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meitei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 300 persons carrying Deadly weapon forcefully entered our locality and vandalised and damaged my rented house at Mandop leirak leikai New Checkon, Imphal East District, Manipur about 44 km South from Saikul-PS. They looted all the household properties including furniture, Jewellery, Kitchen wares, Utensils, Clothes, Books, Documents, rice and grains etc. The approximate value of the lost properties is calculated at about Rs. 5,00,000/- (five lakhs).

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.


