Imphal East about 42 km South from Saikul- PS. They vandalised my rented house and looted all the moveable properties, Furnitures, Utensils, Kitchen Wares, Electrical and Electronic items, rice and grains and important documents, jewellery etc and leaving us homèless.

The approximate value of lost property is calculated at about Rs. 1,00,000./(One lakhs)

It is, therefore, requested you to kindly registered a regular case and take necessary lega action against the culprits according to law.
