I have the honour to state that, On 04-05-2023 at around 6:30 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 800-900 persons carrying sophisticated weapon like AK Rifles, SLR, INSAS and .303 Rilfes, forcefully entered our locality at Newlambulance. Imphal about 42 km South from Saikul-PS. They burnt my rented house to ashes after vandalising looting all the moveable properties, Furnitures, Jewellery, Utensils, Kitchen Wares. and Electronic items, Books including one two wheeler NTORG bearing Reg no. Mn065D2577 and leaving us homeless.

The approximate value of lost property is calculated at about Rs.6,00.000./- (Six lakhs)

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
