Imphal East about 42 km South from Saikul-PS. They burnt my rented house to ashes after looting all the moveable properties, Furnitures, Jewellery, Utensils, Kitchen and vandalising Wares, important documents, computer, laptops Electronic items, Books and leaving us homeless.

The approximate value of lost property is calculated at about Rs.2,00,000./- (Two lakhs)

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
