I have the honour to state that, On 03-05-2023 at around 7:30 pm some unknown persons suspected to be a members of Meitei Youth Organisations, Meitei Leepun, Kangpokpi Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 800-900 persons carrying sophisticated weapons like AK Rifles, SLR, INSAS and .303 Rifles, forcefully entered our locality at Chasad Village, Imphal-East Dist. Manipur about 43 km South from Saikul-PS. They burnt my rented house to ashes after vandalising and looting all the moveable properties, Furnitures, jewellery, clothes, important document, Kitchen Wares, Electrical and Electronic items, Books, cash etc. leaving us homeless.

The approximate value of lost property is calculated at about Rs. 10,00,000./- (Ten lakhs)

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
