Sir,

I have the honour to state that, On 05-05-2023 at around 1:30 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) carrying sophisticated weapons like AK rifles, INSAS, SLR, .303 rifles forcefully entered our locality at New Cheekon, Imphal West District, Manipur, about 46 km South from Saikul-PS. They vandalised my rented house and looted all the moveable properties.

1. Furnitures - Bed, Bed Box, Almirah, Dressing Table, Sofa Set, Table, Dining Table, Dining chair, Study table study chair, Shoe rack, Gas box Jumbo Box (big and small).
2. Jewellery (Gold 10 san)
3. Television, Laptop, Tv stand, Fridge, washing machine, Fan.
4. Gas stove & cylinder, Syntex.
5. Utensils, Clothes, 4 x Mattress, Books, rice and grains etc.

The approximate value of lost property is calculated at about Rs. 25,00,000/- (twenty five lakhs).

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
