


Manipur, we booked flight tickets and flew out to Shillong on 10th May, 2023. It was clear that the Meitei mob had attacked us with the help of Arambai Tenggol merely because we are non-naga tribal Christians. I am a tailor and my shops containing 4 sewing machines, multiple fabrics of different qualities, tables, sofa set, fabric stand, mirrors and decorations worth around 6 lakh rupees were burnt to ashes.

All our household items, washing machine, refrigerator, sofa set, 3 almirahs, bed sets, dining set, clothes, wardrobe, are all lost. The mental trauma has been deep and agonizing as any sound triggers panic attack and sleepless nights follow me to this day. I wish I could someday have a full night's sleep.

There is no way we can continue to reside with the valley(Meitei) people in the valley. So, the only solution is separate administration so that the people in hills and valley can reside as neighbouring communities.

Hence, we request you to restore normalcy and punish the perpetrators of these crimes and provide us a new home where we can feel safe and secure, as we are hoping for justice.

Respected Sir,

We are the residents of the above address since 30 years and have been staying in rented residence.

On 4th May 2023, at around 11:00 am, we heard the sound of war bells and shouts of multiple people. Around 30-40 meitei mobs/militants threw bricks, stones, rocks at our shops and residences, after which they threw the petrol bombs inside the windows. This attack went on incessantly for hours. We somehow managed to escape to nearby houses where we hid for hours.

The Manipur State Police who were stationed there were of no help but instead just watched on as our houses and shops were burnt to ashes. The Army then came with 3-4 trucks after dispelling the crowd. We were then taken to 1st MR Camp in Old Lambulane where we stayed for 6 days and 5 nights with more than 7000 other displaced people. With the help of relatives staying outside


