On the 4th of May Meiter Mobiled by Arambai Tenggol Miscocants attack our locality petting Stone and petrol bombs descroteng Kuti Baptest Convention (+BC) Church New Lambulane, Fearing for our life we were escorted to Leinakhorg Iodian Army HQ under the Protestion of Assam Rifles. On the 12th of May the Army dropped us to huphal airport and then we slew to stilling

I and my siblings had to flee the state, being taki tribe, fearing for our life. We had possessione including furniture, juvellery, electronics, and various household materials worth Rs. 20 Lakhs (approx.) in our house, one Four wheeler and one two whiler worth Rs. 12 lakhs (offred), and a house plot at Mateinal Games village worth \$3.7 lakly we had no idea if anything is still intact, looted or destroyed, or will be retrievable in the near future.

Hence, I request that you will investigate the matter and tate proper action against the peopletrators

We are hoping for justice for all who are in this Plig Listo Pokg
